RESULT(S):

Analysis of Exhibits BM43A, BM43B, and CP11 failed to give chemical indications for the presence of semen.

Semen was not identified on Exhibit BM26.

No further testing was conducted on Exhibit CP12, see report dated April 05, 1988, FDLE case Number 880331366.

A sample from Exhibit BM32 was extracted, amplified, and typed at the following 13 STR loci plus the gender identification locus amelogenin: D3S1358, vWA, FGA, D8S1179, D21S11, D18S51, D5S818, D13S317, D7S820, D16S539, TH01, TPOX, and CSF1PO.

A DNA profile was not obtained from the STR DNA testing of Exhibit BM32.




